The Szuba Family:

A Legacy of Giving

The Szubas have been members of the Providence Center family for more than 40 years, when the youngest child of Carl and Doris was enrolled in the Center's programs at the age of three. Throughout their four decades relationship with the Center, beginning with Carl and now with his son Mike, the Szubas continually seek new ways to support Robert and the important programs he receives at the Center. Today, Mike is carrying on Carl's legacy of finding ways to raise awareness and funds for the Center that supports his brother and nearly 500 other men and women with developmental disabilities. "Robert and my father are still my biggest inspirations," Mike Szuba says. "I'm just trying to follow in dad's footsteps and help where I can."

Over the years, the Szuba family has helped raise more than \$500,000 for Providence Center's programs and services. Carl was relentless - collecting everything from dollars to pennies to support the Center. He set up a fund, "God's Special Children," with monies he raised or collected through carnival wheels, Polish Dancing events, and driving to the Eastern Shore to sell crab mallets from the Center's Woodshop. He even successfully lobbied La Fontaine Bleue in Glen Burnie to donate the wishingwell coins from their fountain to Providence Center's programs.

Robert is the youngest of six children. Carl made it a family affair as he sought ways to support the programs that Robert was accessing, often bringing several of the Szuba children with him to assist with activities on behalf of Providence Center. "Dad wanted these programs to be available for years to come," Mike states. "So we learned to do our part."

After Carl passed away in 2001, Mike knew he wanted to use his talents to help Providence Center. Mike explains, "A few years after dad passed, I knew I could find my own way to support the programs that Robert continues to count on. Because of that, I decided to incorporate my hot rod hobby into a fundraising event." Jalopyrama, as it is called, debuted in 2004 at the Glen Burnie Armory.

That first year, 80 cars flocked to the Armory to be displayed as part of the inaugural show. From there, the event gained more steam each year. "The first year, we raised \$750 and the next year we doubled that," Szuba says proudly. Jalopyrama has since grown significantly and has even gained national recognition, with cars and car enthusiasts coming from across the country to attend this one-day event.

Some have a connection to those living with developmental disabilities. Many have no direct connection at all. But they are all helping us meet our mission of service and giving those we serve a chance, an opportunity, a door-opening, life-changing experience.

To help others get involved in their communities, each day our staff is working to train and build the skills of many of those

Providence Center Meets with County Delegation as 2013

County Delegation as 2013 General Assembly Session Kicks Off



Since adopting a personcentered planning approach several years ago, Providence Center has placed itself ahead of the curve in providing services for adults with developmental disabilities. By putting participants' wants, needs, and dreams at the forefront of designing each individual's service plan, this approach ensures that those served set their own goals for their lives and a path to

achievement. In January, Providence Center Chief Executive Officer Chuck Coble met with the Anne Arundel County Delegation of the Maryland General Assembly to talk about the success of person-centered planning and the need for ongoing support from the State of Maryland for providers that continue to seek ways to assist those with disabilities to achieve greater independence in their lives.

The 20 members of the Anne Arundel County Delegation, led by Delegate Nic Kipke (District 31) for the 2013 session, listened intently to the brief presentation by Coble and voiced their support for a productive role by the State of Maryland in the delivery of services to those with disabilities.

"It is important for us to talk about what we do and the extraordinary individuals we serve with our elected officials," Coble said. "An ongoing dialogue with our elected officials is critical to advancing lives. The Anne Arundel County Delegation has served as effective advocates for the nearly 500 individuals we serve and the more than 7000 adults with developmental disabilities in Anne Arundel County. We are very grateful that they took the time to hear from us and offer their ongoing support as we move forward in shaping lives and creating futures for all Providence Center participants."

Additional items discussed with the Delegation included the impact of the State's change in policy to not fund absentee days on Providence Center's programs and services. Coble informed the members that it has had a significant impact, and while our staff and participants have worked diligently to keep attendance relatively high, it is an issue that requires close monitoring and has impacted the Center's fiscal health.

This is the Maryland General Assembly's 433 Legislative Session. The session runs for 90 days from January to April.

In October, the 9th Annual Jalopyrama was held with more than 1500 people in attendance, even with Hurricane Sandy bearing down and with dark clouds covering the sky. The show raised \$12,575 for Providence Center's programs and services – the largest raised in the show's history.

As planning begins for the 10th year of the show, Szuba is working hard to build on the momentum and attract even more people to the event, seeking to go beyond hot rod lovers to include car aficionados, Providence Center supporters, and the Anne Arundel County community at large. Mike's dedication to

mixing of his love of hot rods with his desire to support his brother and the nearly 500 men and women of Providence Center has even inspired other car lovers to host events for the Center and support its work even more.

Over the years, Robert Szuba has grown with the organization, transitioning with Providence Center to adult services and gearing his services towards learning skills and earning a living through job training. Today, Robert is an enthusiastic grower in the Center's Horticulture program. "Robert deserves the same opportunities as anyone else," Mike says. "And with the support of the staff, he is making his own way in the world and earns a paycheck each week. These programs are an important part of his life and his desire to be as independent as possible."

Active families like the Szubas are important to sustaining the Center's programs and for ensuring that participants receive the most out of their lives as possible, according to Chuck Coble, Providence Center's Chief Executive Officer. "The entire Szuba family has been critical to Providence Center's doors being open for 52 years. Robert has grown with us and he designed and is achieving a life for himself. He has challenged himself and is an extraordinary person. The same can be said for Carl and Mike. Their support of Robert and our work is so much more significant than the dollar amounts they have raised for our programs – and they have raised a lot of money over the years. Mike is committed to making life better for those with developmental disabilities and keeping our fantastic staff in place. He has taken his father's mantle and is making an ongoing positive impact on the lives we serve."

Our Lawn Care Crew Ready to Help with the Community's Spring Landscaping Needs

Greg Marin, a landscaper with 27 years of experience, began working as Providence Center's Lawn Care Manager in August 2012, hoping to further propel the Lawn-Care Crew program. This program is an essential part of Providence Center's production programs, as it promotes our organization to new clientele, gives our participants a source of income, and integrates them into the community. Through this employment program, the individuals are encouraged to leave their comfort zone and interact with their neighbors in the community, thus building confidence and strengthening necessary communication skills as well as develop landscaping skills that can translate to future work opportunities.

The Lawn Care Crew, which is currently comprised of 12 trained, qualified adults enrolled in Providence Center's programs, offers a full range of landscaping services. Services include: grass cutting, landscaping design, planting of trees, shrubs, and flowers grown in our horticulture program, leaf and lawn clean up.

Marin embraces his role as mentor to the participants in the program. "I want to teach those in the program the trade and build their skills," Marin said. He hopes to grow the program to recruit new individuals, and eventually have two separate groups for lawn care and landscaping. Each participant will be fully trained and exposed to the job through in-house lawn care for Providence Center's five sites. Marin stresses that crew members are as skilled and capable as any other professionals in the field.

As the spring season approaches, please consider hiring our Lawn Care Crew for your landscaping and lawn care needs. In addition to providing superior quality work, all of the adults with developmental disabilities in this program will benefit from more experience and new opportunities to show the community their capabilities. Woodshop at New Home at Baldwin Industries

On February 18th, 30 woodworkers, along with their staff, moved from their rented space in Millersville to their new modern woodshop located at Providence Center's Baldwin Industries in Arnold. This move culminates months of planning, a significant construction project and a lot of hard work – all to enhance the service we provide to those that count on us. "This has been a team effort from our staff at Woodshop and Baldwins, our construction team, and funders in the community to enrich and expand services to those in our Woodshop and Baldwins programs," said Chuck Coble, Providence Center's Chief Executive Officer.

The project was generously funded by the Jesse and Hertha Adams Charitable Trust to offer our Woodshop participants a modernized space from which to learn job skills and create products for the community to enjoy. "This is a wonderful move for us," said Precola Wilson, Program Coordinator of the Woodshop Program. "Not only do we have a modern, comfortable program area, our woodworkers can now take advantage of the vocational training programs at Baldwins. The move also opens up the opportunity for our participants to interact more with their community." She added that everyone is settled in now, hard at work on children's Adirondack chairs and happy to be in their new home.

The new Woodshop is already hard at work producing Providence Center's wood products for sale.

Ronald Russell, one of Providence Center's woodworkers who has been with the Center for 30 years, agreed and says he feels good about the move. When asked what he liked best about the new space he said, "Everything! Everything around me." His coworker David Baumgardner is also glad to be working in the new woodshop, "I like the new finishing room and machine room the best," he said.

The Woodshop relocation project is part of Providence Center's ongoing work to support our current participants to design richer, fuller lives for themselves, as well as to build the foundation to prepare for those future generations who will count on us for support.
