Beliefs & Values

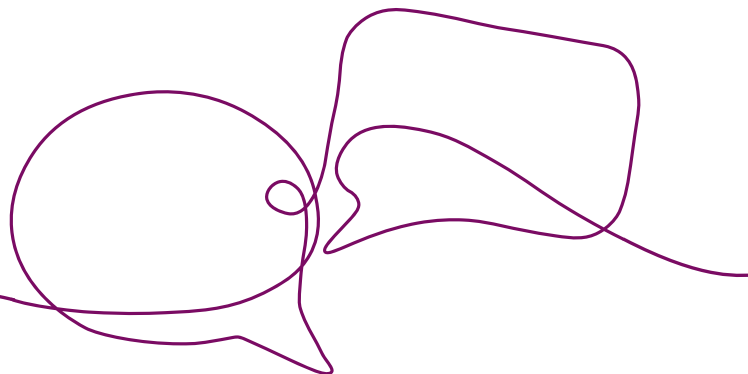
Our Beliefs

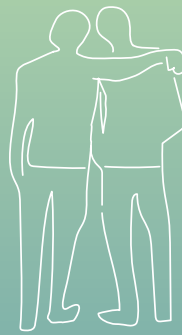

Providence Shares New Brand With Community

In July, we unveiled Providence's new logo and name, and began the final phase of a brand update designed to celebrate our important history and ensure our brand best conveys who we are as an organization and our vision for the future.

Our first step was to officially change our name from Providence Center to Providence of Maryland, or Providence for short. Removing the word "Center" more accurately reflects the work we do to support people to live their best lives in their communities, rather than providing supports within a building.

Our new logo introduces fresh colors along with the Providence signature teal, and the design reflects our

focus on each person, and our work to provide supports and services within the community as much as possible.

Our logo's knot-like structure conveys a sense of community, interconnected by our personal paths and experiences, and made whole with everyone's contributions. The design also reflects our vision for a community where every person has the opportunity to live their best life. The three components of our new tagline: Real Connections. Real Opportunities. Real Experiences. are implied in the design.

We are proud of our new look and so appreciative of all our many stakeholders whose insight was so invaluable to this process.

Providence Expands to Charles County, Adds Community Living Supports

On July 1st, Providence of Maryland completed the merger of Charles County HARC into Providence. This merger was an important step in our efforts to expand Providence's services and geographic reach to strengthen our mission for the people and communities we support.

With the merger, our organization added community living supports, expanding how we mentor and coach people through every aspect of their life, including employment, community engagement, advocacy, and now, home life.

Community Living Services are provided through an established team of more than 80 staff members who work alongside 35 men and women who live in 11 homes.

The merger also brings with it a 62-year reputation of commitment to the people and communities of the Charles County area.



People Living Their Best Lives: Bridgette Fitzhenry

In 1963, a young Bridgette Fitzhenry moved with her family into a home where she would live for nearly 60 years. When her parents passed, her brothers - first Bill then Patrick - lived with her so she could remain in their home. Once her brothers were no longer able to provide Bridgette with assistance living in their family home, Bridgette began living at the homes of her sisters, Laura and Linda, rotating between them. She was happy to be with her family but missed being in her own home very much. In 2023 Providence was licensed to provide supported living services that could assist Bridgette to return to her home. Bridgette and her family were thrilled at the prospect, so Providence got to work recruiting several Direct Support Professionals (DSPs) to provide support in the evenings, overnight and on weekends. By the end of July Bridgette was happily settling back into her beloved home.

Bridgette's sister Linda said, "We are so happy that Bridgette is able to live at home with support from Providence. She is so happy there." She continued, "It's great to see Bridgette living independently and knowing that she has assistance when she needs it from the great staff that have been recruited." Joyce, a DSP that supports Bridgette in the evenings during the week, has developed a deep connection with Bridgette and together they go

grocery shopping, cook meals, take care of household chores, ensure that Bridgette's personal needs are met through doctor visits and managing medications. They are frequently in the community attending events at church and Special Olympics, going shopping at Arundel Mills, meeting friends and family to eat out and watching planes fly over at the BWI Observation Park.

When you visit Bridgette's home, she is happy to give you a tour and tell you stories about growing up there and show you photos of her family that are on display throughout. She is particularly excited to show you her new furniture and her collection of DVDs and videos, puzzles and her various craft projects, plus a huge pile of medals she has won for swimming events with Special Olympics. Bridgette says, "I love my house. I have so many memories here and being back here is perfect." When she's not at home or in the community, Bridgette works at Providence as a Receptionist 3 days a week. She says, "My favorite part of being a Receptionist is answering the phones because I love talking to people." We are so happy that Bridgette is truly living her best life, and we look forward to seeing how Supported Living can help more people do the same.



Partnering With The Big Bean To Provide Job Opportunities

When Christie and Greg Coster purchased The Big Bean coffee shop in Severna Park in 2019, they had a vision to preserve the local coffee shop culture where the community could come in and connect with each other over great coffee in a welcoming environment. The Big Bean was important to them because it was where Christie worked as a Barista over 25 years ago and also where the couple first met. As they set out to realize their vision, they knew that providing work opportunities for people with disabilities was also part of their mission, as Christie's Uncle Joey is supported by Providence and she watched him work in many jobs over the years and witnessed how working gave him a place in the world and helped him have his own life. A couple of years later after getting established in the business, they worked with Providence to hire Allison Hamilton, who was looking for a new opportunity after being laid off from her previous job during the pandemic. It's now been more than 2 years, and Allison is an integral part of The Big Bean team. She works three days a week and the Baristas rely on her to prepare and stock smoothie portions, prep, wrap and stock food and retail items, and keep the coffee stations clean. In fact, Christie said that "Allison took a couple days off over Thanksgiving, and we had a hard time keeping up without her!". Allison loves her job and she said "I want more responsibilities and I'd like to work full-time."

She continued by saying that her favorite part of the job is "working with Mr. Greg. We tease each other and have so much fun." Greg agreed and said that "We love having Allison on our team. She does a great job and both staff and customers love her. We work hard, but we also have a lot of fun."

In addition to locations in Severna Park and Annapolis, Christie and Greg are working on opening a third Big Bean location in Millersville. They are hoping that the expansion will allow them to provide more job opportunities. When asked what she would say to other employers considering hiring a person with disabilities Christie said "Just do it. It will enhance your business and adds a unique element to your work life." She continued by saying, "I really didn't know Severna Park until I worked at The Big Bean. It opened my eyes to how wonderful our community is. We are so glad to be a part of it, and fortunate to work with Providence to provide opportunities that help people find their purpose and place here in the community." We can't wait to see what's next for Christie, Greg, Allison and The Big Bean as they expand and grow, keeping the community and opportunities for all at the forefront of everything they do.





Meet Gloria

Our Direct Support Professionals (DSPs) make our mission work. They are skilled coaches and mentors, and they place great value in building close relationships to guide and shape how they support people to live their best lives.

Gloria Beseris is one of 160 DSPs working alongside more than 300 people who count on Providence. Gloria joined our team in 2022, from retirement, bringing with her years of experience running an assisted living home, a passion for people and a commitment to help people create joy in their day.

At Providence, Gloria works directly with Kyle. “Our goal,” she says, “the goal Kyle and I have together, is to support him to engage with and be in touch with his environment.” Their close relationship makes this possible.

Gloria has gotten to know Kyle and his interests by spending time with him. Those moments are often outside when the weather is nice, enjoying a walk, or if it’s cold, finding a sunny spot together under a window. She says, “Kyle has really gotten to know me too. He connects through sound and knows my voice.”

Knowing Kyle has helped Gloria develop innovative ways to support him to exercise, and use his hands to grab and throw a ball. It has also led to music being a big part of their relationship. Gloria learned early on that Kyle enjoys music and they use a drum for learning and repetition as well as a way to engage together.

Staff have noticed their relationship, and the creative ways Gloria helps Kyle connect to his surroundings and friends including organizing Bingo Fridays and weekly art projects that anyone can take part in.

When asked what drives her work every day, Gloria says, “Kyle of course, and I really like being a DSP.”
